Who we are

What personal data we collect and why we collect it

Provider information

We collect the data that our providers submit to us and their IP addresses.

Provider's Company Name, Business Phone, Company description, Parking Address, Website, Photos will be visible to the public on the Internet, iOS, and Android BD247 Apps, our Telegram bot, our pages on the Facebook, Instagram, Pinterest and can be used in marketing materials. Email is invisible.

Realtime location data of our providers

When providers send us their realtime location data we collect only the last location data.

The location data is visible to the public on the website and iOS and Android BD247 apps

Reviews

When visitors leave reviews on the site we collect the data shown in the feedback forms, and also the visitor's IP address and browser user agent string to help spam detection.

After approval of feedback, the Names are visible to the public in the context of their comments. The Email is invisible.

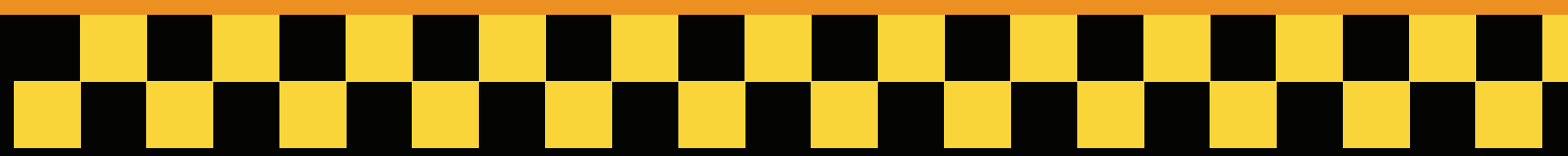
Media

If you send us your images to upload to the website, you should avoid sending images with embedded location data (EXIF GPS) included. Visitors to the website can download and extract any location data from images on the website.

Analytics

Our Site uses analytics services provided by Google. Website analytics refers to a set of tools used to collect and analyse anonymous usage information, enabling us to better understand how Our Site is used. All the data are shown on the site also are visible to the public on BD247 apps, our Telegram bot, our pages on Facebook, and Instagram.

This site is scanned for potential malware and vulnerabilities by Sucuri's SiteCheck. We do not send personal information to Sucuri; however, Sucuri could find personal information posted publicly (such as in comments) during their scan. For more details,

How long we retain your data

Security logs are retained for 14 days.
All other data are retained indefinitely.

What rights you have over your data
